Presenters

Bill Crabtree (B.Aq.Sci., M.Sc. UWA)

Known as "No-Till Bill" for the pivotal role he played in the WA no-tillage revolution. Bill began his career with the WA Dept of Ag as a researcher into "Minimum tillage for wind erodable soils" in his home erosion-swept town of Jerramungup. He then extended this work to farmers in Esperance and the



rest of the state which led to him receiving the "Landcarer of the year award in WA" in 1996.

Bill spent a year in Canada in 1996, learning how they do notillage. While there he co-edited their book Advancing the Art of Zero Tillage which is on the ManDak website. He returned to WA as the Scientific Officer for the WA No-Till Farmers Association for a 5.5-year term.

Bill is now a consultant specializing in no-tillage technologies based in Northam WA. His home state now boasts an 80% adoption of no-tillage and no-tillage has dramatically improved WA's production, especially in the recent droughts.

Tim Starick (B.App.Sci.)

"Years of local Experience"

Tim has been working closely with Victorian farmers since graduating in the late 1980's. Tim is an agronomist with Landmark in Horsham and is the inaugural Secretary of Vic No-Till.





Danny Conlan (B.App.Sci.[Agric.])

Danny has been an independent consultant for 2 years after a 10-year stint as a company agronomist. He also farms at Sea Lake.

Why adopt no-tillage?

Soil erosion is not sustainability. Tillage causes both wind and water erosion. No-tillage with stubble retention stops almost all erosion. Stubble retains moisture and softens the soil through its breakdown via microbes in the soil. This softer soil improves soil aeration, reduces compaction and improves soil water infiltration.

These facets take a few years show their true power. However, it is in droughts that the improved soil most expresses its improved buffering capacity. In wet conditions there are also improvements in aeration and trafficability.

No-till is now no longer considered a fad.

It is a serious farming system that is being adopted all over the world with profound benefits. However, there are some traps for new players. These Seminars will help you avoid these traps.

Benefits of no-tillage include:

- Earlier time of sowing
- Softens heavy soil, stabilizes light soil
- Controls wind and water erosion
- Better weed control—making Trifluralin more effective
- Harvests water, improves infiltration
- Enables efficient moisture seeking.
